The selection of candidates in category III above should be entirely on merit among the eligible candidates in this category.

The Children of All India Service Officers posted in the UT of J&K would also be eligible to participate in the said merit system.

In addition to above, the following certificates shall be enclosed with the applications:-

1. Date of Birth Certificate (Matriculation).
2. 10+2 Marks Card.
3. NEET-UG 2024 Score Card (as per qualifying marks for NEET-2024)
4. Domicile Certificate issued by the Competent Authority.
5. Reserved Category Certificate, if any (Reservation as applicable to J&K).
6. ID Proof.
7. Two Passport Size Photographs.
8. Preference of Colleges (Lady Hardinge Medical College New Delhi is meant for females only).
9. Certificates/ Documents from the Competent Authorities as detailed in the above table.

The last date for submission of applications with full details/ documents shall be upto **28.08.2024 (till 3.00pm)**, no application shall be entertained after the cutoff date.

Note.

1. Mere submission of documents/applications by the candidates shall not confer any right on the candidate to claim the seat, which shall be decided by the appropriate authorities of the Government in accordance with the merit/eligibility criteria prescribed by the concerned authorities.
2. The selection of eligible candidates will be made as per guidelines issued under Office Memorandum No. U. 14014/16/2022-ME-II dated 12.08.2024 of Ministry of Health & Family Welfare, Government of India, New Delhi.
